

REAL ESTATE PURCHASE AND SALE AGREEMENT

State of District of Columbia | Cash Transaction | Investor Form

1. PARTIES. This Purchase and Sale Agreement ("Agreement") is made effective as of _____, 20____ ("Effective Date"), by and between _____ ("Seller"), and _____ **and/or assigns** ("Buyer"). Buyer and Seller are together the "Parties." If the date above is left blank, the Effective Date is the date of the last signature below.

2. PROPERTY. Seller agrees to sell and Buyer agrees to buy the real property located at: Street address: _____, City: _____, County: _____, District of Columbia, ZIP: _____. Parcel ID: _____. Legal description (attach if lengthy): _____

The sale includes all fixtures, improvements, and appurtenances, together with the following personal property, if any:

3. PURCHASE PRICE. The total purchase price is \$_____ (_____ Dollars), payable in cash or immediately available funds at Closing. **This is a cash transaction. Buyer's obligation to close is not contingent on financing or appraisal.**

4. EARNEST MONEY. Within _____ business days after the Effective Date, Buyer will deposit \$ _____ as earnest money ("Deposit") with _____ ("Escrow Agent"), to be held in escrow and credited to the purchase price at Closing. If this Agreement is terminated during the Inspection Period under Section 6, or due to Seller's default or failure of title, the Deposit will be promptly refunded to Buyer in full. If the Parties dispute the Deposit, the Escrow Agent may hold it pending joint written instructions or deposit it with a court of competent jurisdiction, and is released from liability upon doing so.

5. AS-IS CONDITION. Buyer is purchasing the Property in its present "**AS-IS, WHERE-IS**" condition, with all faults, whether known or unknown. Seller will make no repairs and gives no warranties regarding the condition of the Property, except for any disclosures required by applicable law, which are summarized in the Disclosures section of this Agreement. Seller agrees to maintain the Property in its present condition, ordinary wear excepted, and to deliver it at Closing free of tenants and occupants unless stated here:

6. INSPECTION PERIOD. Buyer has _____ calendar days from the Effective Date ("Inspection Period") to inspect the Property and investigate all matters Buyer deems relevant, including condition, title, survey, zoning, and feasibility. Buyer and Buyer's agents, contractors, partners, and assigns may access the Property at reasonable times with prior notice. **Buyer may terminate this Agreement for any reason or no reason by written notice to Seller before the Inspection Period expires, in which case the Deposit will be refunded to Buyer and neither Party will have further obligation.** If Buyer does not terminate before the Inspection Period expires, the Deposit becomes non-refundable except as otherwise provided in this Agreement.

7. ASSIGNMENT. Buyer may assign this Agreement, in whole or in part, to any person or entity without Seller's consent. Upon assignment and the assignee's assumption of Buyer's obligations, the original Buyer is released from further liability under this Agreement. Seller acknowledges that Buyer is an investor, may assign this Agreement for a fee or other compensation, and may market its contractual interest in the Property to prospective assignees during the term of this Agreement.

8. MARKETING AND ACCESS. During the term of this Agreement, Seller authorizes Buyer to advertise and market Buyer's contractual interest in the Property, to show the Property to Buyer's partners, lenders, contractors, and prospective assignees, and to place a lockbox or signage with Seller's consent.

9. CLOSING. Closing will occur on or before _____, 20____, or earlier by mutual agreement, at the office of the closing agent designated by ☐ Buyer ☐ Seller. Possession transfers to Buyer at Closing. Buyer may extend Closing by up to _____ additional days by written notice if reasonably required to complete title or closing matters. Seller represents that Seller is not a "foreign person" under the Foreign Investment in Real Property Tax Act (FIRPTA); if Seller is a foreign person, the Parties will comply with the withholding requirements of 26 U.S.C. Section 1445 at Closing.

10. RISK OF LOSS. Risk of loss remains with Seller until Closing. If the Property is damaged by fire, casualty, or other cause before Closing, Seller will notify Buyer promptly, and Buyer may (a) proceed to Closing with an assignment of Seller's insurance proceeds relating to the damage plus a credit for any deductible, (b) accept the Property in its damaged condition with a price adjustment agreed by the Parties, or (c) if the cost to restore exceeds _____% of the purchase price, terminate this Agreement and receive a full refund of the Deposit.

11. TITLE. Seller will convey good, marketable, and insurable title by ☐ Special Warranty Deed is customary for arm's-length residential sales ☐ General Warranty Deed ☐ Special Warranty Deed, free of liens and encumbrances except easements and restrictions of record that do not impair the use or value of the Property. If a title examination reveals defects, Buyer will notify Seller in writing and Seller will have _____ days to cure. If defects are not cured, Buyer may (a) extend the cure period, (b) accept title as-is, or (c) terminate this Agreement and receive a full refund of the Deposit.

12. CLOSING COSTS AND PRORATIONS. Unless stated otherwise here, Buyer pays: closing/settlement fees, title search and owner's title insurance, and recording fees for the deed. Seller pays: satisfaction and release of existing liens, and Seller's own payoff costs. Real estate taxes, assessments, HOA/condo dues, and utilities will be prorated as of the date of Closing. Other terms:

13. DEFAULT. If Buyer defaults after the Inspection Period and Seller is not in default, Seller's sole and exclusive remedy is to receive and retain the Deposit as agreed liquidated damages, and this Agreement terminates. If Seller defaults, Buyer may (a) terminate and receive a full refund of the Deposit, or (b) seek specific performance of this Agreement.

14. NO COMMISSIONS. The Parties represent that no real estate broker or agent is involved in this transaction unless listed here, and each Party will indemnify the other against commission claims arising from that Party's own conduct. Broker(s), if any:

DISTRICT OF COLUMBIA DISCLOSURE REQUIREMENTS (SUMMARY)

Seller's Property Condition Disclosure Statement (D.C. Code ss.42-1301 to 42-1311): Seller of residential property with 1-4 dwelling units (where the purchaser states in writing an intent to reside there) must deliver the Mayor-approved disclosure form before or at the time the purchaser executes the purchase agreement; if delivered late, purchaser may terminate within 5 calendar days of receipt (right ends at loan application with lender notice, settlement, or occupancy). (Applies: residential 1-4 units, owner-occupant purchasers (exempt: court-ordered/foreclosure/fiduciary, family and co-tenant transfers, government, new never-inhabited construction).)

Soil Characteristics Disclosure (D.C. Code s.42-608): Every contract conveying DC real property must state the characteristics of the soil on the property (per the Soil Conservation Service 'Soil Survey' classification) and include a notation that further information can be obtained from a soil testing laboratory, the DC Department of Environmental Services (now DOEE), or the Soil Conservation Service; contracts must also note any Heritage Tree on the property and removal restrictions. (Applies: all real property conveyance contracts in DC.)

Underground Storage Tank Disclosure (D.C. Code s.8-113.02(g)): Seller must inform the buyer IN WRITING, before entering into the contract of sale, of the existence or removal of any underground storage tanks of which the seller has knowledge (existing tanks or tanks removed during the seller's ownership); standard DC contract forms carry a UST disclosure paragraph; enforcement/penalties via D.C. Code s.8-113.09. (Applies: all real property sales in DC.)

Tenant Opportunity to Purchase Act (TOPA) (D.C. Code s.42-3404.01 et seq.; single-family exemption s.42-3404.09(1A)/(1B) via D.C. Law 22-120 (2018)): Before selling a rental accommodation, owner must give tenants a statutory offer of sale and opportunity to purchase. Since July 3, 2018, single-family accommodations (including SFD with one ADU or a single rental condo/co-op unit) are EXEMPT, except elderly (62+) or disabled tenants with leases signed by March 31, 2018 and occupancy by April 15, 2018 retain rights; owner of an exempt single-family unit with a tenant must still give the tenant notice within 3 days of receiving an offer so the tenant can claim elderly/disabled status (20 days to respond). (Applies: rented residential accommodations; vacant single-family sales handled in practice with a TOPA vacancy/exemption affidavit at settlement rather than a full offer of sale.)

Condominium Resale Certificate (D.C. Code s.42-1904.11): Condo resale requires the seller to furnish a resale certificate from the association (assessments, budget, reserves, litigation, insurance, capital expenditures) on or before the 10th business day after contract execution; purchaser may cancel within 3 business days after receipt (or if documents are never provided), with full deposit refund; cooperative resales are handled analogously under co-op documents. No verbatim contract text mandated. (Applies: condo units (co-ops analogous).)

Lead-Based Paint (federal, homes built before 1978): the EPA/HUD "Disclosure of Information on Lead-Based Paint and/or Lead-Based Paint Hazards" must be completed and attached, and Buyer acknowledges receipt of the pamphlet "Protect Your Family From Lead In Your Home."

Closing Practice Note: recorded instruments: Notary acknowledgment only; D.C. Code s.42-401/s.42-101 requires deeds to be acknowledged and recorded, no witnesses required. FP-7/C transfer tax return must accompany the deed for recording..

15. DISCLOSURES ACKNOWLEDGED. The Parties acknowledge the disclosures summarized above. 16. MISCELLANEOUS. This Agreement (a) is the entire agreement of the Parties and supersedes all prior negotiations; (b) may be amended only in a writing signed by both Parties; (c) is governed by the laws of the State of District of Columbia; (d) is binding on the Parties and their heirs, successors, and permitted assigns; (e) may be

signed in counterparts, and electronic or scanned signatures are effective as originals; (f) time is of the essence; and (g) if any provision is held unenforceable, the remaining provisions continue in effect.
